**Subject:** Support to the victims during the trial of the terrorist attack committed in Nice on July 14h, 2016.

Madam, Sir,

The trial related to the attack committed in Nice on 14 July 2016 will be held before the Criminal Court from 5 September to mid-November 2022, at the Paris Court of Appeal located at 8 boulevard du Palais in the 1st district of Paris and broadcasted at the Acropolis, 1 Esplanade John Fitzgerald Kennedy in Nice.

In this regard, we would like to inform you that, as a civil party, you have the possibility of attending the hearing at the Courthouse in Paris, in the non-interactive broadcasting room in Nice or by web radio from your home.

The Public Prosecutor at the Paris Court of Appeal has entrusted the associations "Paris Aide aux Victimes" and "Montjoye", approved by the Ministry of Justice, with the task of providing information and psychological support to the civil parties in this trial. Support workers and psychologists will therefore be available throughout the trial.

In this context, Paris Aide aux Victimes and Montjoye, members of the France Victimes federation, offer you:

- 2) A questionnaire (attached), to organize and adjust the scheme to your needs as best as possible. We know that it may be premature for you to answer questions that are too precise, but your answers will be valuable.
- 3) An information meeting on the organization and practicalities of the trial and a visit to the courtroom (date to be announced).
- 4) A vade mecum with the practical modalities concerning the trial (courtroom in Paris and retransmission in Nice), the web radio, the reimbursement of expenses (in progress).
